### BACKGROUND

The rule of law is fundamental to ensuring the fairness of society and is characterized by transparency and accountability in both the public and private sectors. Such transparency and accountability may only prevail if a functioning judicial system is in place, acting as one of the cornerstones of a society. Populations need an efficient legal system in order to resolve disputes in all forms and guarantee an impartial application of laws and rules, as enshrined in the rule of law.

This training activity aims at covering not only the core aspects of the rule of law, but also touches upon the fundamental principles of human rights and governance in to provide participants with a holistic vision of the interconnectivity of these vital legal issues. Given that due to gender stereotypes women are frequently underrepresented in key positions in the legal sphere, reducing the representativeness of the respective judicial system, the course will also pay special attention to the role women can play on strengthening the rule of law.

## METHODOLOGY

In light of the ongoing global pandemic and related travel restrictions the training programme will be held exclusively online via the platform zoom enabling participants from different countries to join and engage in peer-to-peer learning without necessitating travel.

UNITAR's training programmes are designed to be highly interactive and participatory and will include a variety of simulation exercises and pedagogical tools to enable participants to acquire a thorough knowledge and understanding of the core legal issues, while also promoting a gender-sensitive approach.

The e-workshops will be built on the following pedagogical pillars: concept learning (lectures, presentations), experience sharing (panels, working group discussions) and exposure to real world problems and policy choices.

Participants will be provided with a comprehensive set of training material, prepared in close cooperation with the resource persons, consisting of copies of presentations, selected readings, instructions for the interactive exercises and discussion group assignments, relevant publications, etc. The material, enabling participants to partake in a well-informed, effective and prepared way, can also be shared with colleagues who have not benefited from the training.

## TARGETED AUDIENCE

The workshop is open to up to 35 participants from the ECLAC region who are either:

- Members of the private sector,
- Members of Permanent Missions accredited to the United Nations,
- Delegates of Ministries of Foreign Affairs and other government officials,
- Representatives of international, intergovernmental and non-governmental organizations
- Academia and students interested in the field of business and human rights.
